Terms of Contract and Conditions for Corporate Support

1. Terms of Payment

The Corporate Support Contract Form must be submitted along with at least 25% of participation costs. Further payments to be made as follows : 50% by 10-03-2016 and balance 25% by 31-03-2016 along with the Govt. Service Tax.

All payments must be made by crossed cheques / DD drawn on Mumbai / New Delhi banks payable in Mumbai in favour of India - Tech Foundation.

2. Withdrawal of Support

50% of the amount paid towards participation charges will be refunded, if the Supporting Organisation written notice for withdrawal from Corporate Support is received by the organizers before 10-03-2016. On withdrawal after 10-03-2016 all payments made by the organisation shall be forfeited. Failure to provide the material such as Logo, Advertisements, Names and Designation of the Delegates, one month prior to opening of the Exhibition / Conferences and non-payment of full Corporate Support charges as per given schedule will be treated as withdrawal from participation. In such cases, all payments made by the Organisation shall be forfeited.

3. Changes of Venue Dates etc.
